Ltd.), a company incorporated under the provisions of the companies Act, 1956 and having its registered office at (hereinafter referred to as 'SJL' or supplier of the product and services which expression shall, unless the context otherwise permits, include its successors and permitted assigns) of the First Party. (Company)

And

WHEREAS

- a) "SJL" is engaged in the business of providing product and services via direct sales solutions.
- b) "Distributor" is engaged in the business of marketing of various products and will be working as distributor.
- c) The second parties have approached to expressed their desire to tie-up with first party for the product and services of their respective portfolio in the manner and on the terms and conditions appearing hereinafter.

Terms & Conditions

1. The applicant should read thoroughly and understand the terms and conditions, policies, procedures, code of ethics and business opportunities of the company as given below and from the website named "www....."
